## SALE OF SURPLUS PERSONAL PROPERTY NO LONGER NEEDED FOR PUBLIC USE ON AN ONLINE AUCTION WEBSITE

WHEREAS the Board of Fire Commissioners of Hopewell Borough Fire District #1 in Mercer County, New Jersey, has determined that a 1992 Federal Pumper owned by the fire district is surplus property no longer needed for public use; and

WHEREAS the commissioners believe it is in the best interests of the fire district to sell said surplus property through an on-line auction conducted by the approved Internet-based vendor GovDeals.com.

IT IS HEREBY RESOLVED by the Commissioners of Fire District No. 1 in the Borough of Hopewell Mercer County, New Jersey, as follows:

- The sale of surplus personal property no longer needed for public use shall be conducted through GovDeals
  pursuant to New Jersey State Contract A-83453/T2581 in accordance with the terms and conditions of the State Contract and
  any renewals thereof.
  - The sale will be conducted online and the address of the auction site is govdeals.com.
- 3. The sale is being conducted pursuant to NJSA 40A:11-36(1) and the NJ Division of Local Government Services' Local Finance Notice 2008-9 as updated by Notice 2008-21 and 21R. The terms and conditions of the Agreement entered into with GovDeals are available online at <a href="https://www.govdeals.com">www.govdeals.com</a> and also are available in the office of the Clerk of Hopewell Borough Fire District No. 1.
- The surplus property to be sold is a 1992 Federal Pumper, VIN# 4ENRAAA8XN1009921, and the odometer reading is 35422 miles.
- The surplus property as identified shall be sold in "as is/where is" condition without express or implied warranties of any type and the successful bidder shall be required to execute a Hold Harmless and Indemnification Agreement concerning the ownership and use of the property.
- 7. The fire district shall reserve the right pursuant to GovDeals Terms of Agreement to accept or reject any bid submitted and/or, prior to or after the close of the sale to reduce the reserve, to make an offer to the highest bidder if the reserve is not met, and/or to make an offer to the second highest bidder upon default of the highest bidder.
- Notice of the Sale of Surplus Equipment shall be published in the official newspaper of the fire district and the auction shall begin thereafter as allowed by law.
